#### I. Board Business

A. Board Resolutions and Approvals: New Board Member, Amy D'Angelo (5 mins)

## A. Finance Update (10 mins)

Omar Mayyasi presented the financial report, mentioning the main drivers in the budget, personnel savings, use of ESSER funds, and a balanced budget for fiscal year 2024 with a slight surplus projected. Mr. Mayyasi discussed revenue decline, per pupil increase, personnel costs adjustments, healthcare premium increase, and savings on non-personnel costs for fiscal year 25 budget. Mr. Mayyasi shared the need to monitor staffing levels and potential mix between consultants and full-time staff based on actual hires. He mentioned the commitment to stay within the total budget of 13.6 million and provide updates on any variances at upcoming finance meetings.

Ms. D'Angelo mentioned to consider hosting events like a family barbecue to build community and cohesion among staff over the summer. Ms. D'Angelo also shared that principals identify top staff at risk of leaving over the summer and the board could determine support needed to increase retention. There was a discussion on the importance of quality teachers and their role in the success of students.

#### III. Board Business

A. Board Resolutions and Approvals: Finance Approvals (5 mins)

Dick Ferguson made a motion to approve the finance resolutions. LaVonta Bryant seconded the motion. All in favor, none opposed or abstained.

- 2. BE IT RESOLVED, the Elm City College Prep Board of Directors hereby ratifies the re-appointment of CohnReznick to perform the financial audit of the 2024-25 fiscal year and prepare the IRS Form 990s.
